- 5 The Customer/Guarantor hereby irrevocably grants to McGraths Limestone (Cong) Ltd. full right, liberty and licence to enter upon the premises owned or occupied by the Customer/Guarantor for the purpose of repossessing goods unpaid for.
- 6 This Credit Agreement is determinable at the sole discretion of McGraths Limestone (Cong) Ltd.
- 7 Where payment is to be made by Direct Debit, you the Customer/Guarantor shall have a lead time so that any queries relating to Invoices or outstanding balances can be dealt with before the Direct Debit takes effect.
